Counter Piracy: Challenges, Responses and Lessons Learned

Piracy and Sea Robbery Conference 2013

9 April 2013, Pan Pacific Hotel, Singapore

1. The ReCAAP ISC, BIMCO, INTERTANKO and RSIS jointly organised the Piracy and Sea Robbery Conference 2013, on 9 April 2013 at Pan Pacific Hotel, Singapore. The fifth event in the series was held in conjunction with the Singapore Maritime Week 2013.
2. The theme of this year's conference was *Counter Piracy: Challenges, Responses and Lessons Learned*. The aim of this Conference was to provide a platform for all to share information and views on the situation of piracy and robbery at sea, exchange ideas, share best management practices, and address and appreciate challenges encountered by government agencies, ship owners/operators, ship masters and crew.

The Piracy and Sea Robbery Conference 2013 featured addresses and presentations by distinguished speakers, including the Chairperson of the ReCAAP ISC Governing Council, Regional Coordinator of the International Maritime Organization (IMO), and a representative from Asian Shipowner's Forum (ASF).
4. At the opening remarks delivered by Ambassador Dr Pornchai Danvivathana, Governor (Thailand), also the Chairperson of the ReCAAP ISC Governing Council, acknowledging that "No one party or agency can do it alone, it is a shared responsibility and each one of us in our circle of work, contacts and capacity can make a difference by being part of the ReCAAP network." He added that although there had been a consecutive downward trend in the year-on-year number of piracy and armed robbery incidents against ships in Asia since 2010, including the first quarter of 2013 as compared to the first quarters of the past three years, there is no room for complacency.
5. The first session of the Conference covered the overview and perspective of piracy and armed robbery against ships. It started with ReCAAP ISC appraising the participants of the latest trends, and assessments of piracy and sea robbery situation in Asia in 2013. Case studies for best management practices and lessons were then shared, followed by IMO presenting IMO's international efforts and initiatives. Lastly, the ASF shared the perspective of Asian shipowners.

6. The second session was an interactive panel discussion between a panel of experts and audiences, on whether regional maritime cooperation efforts to counter piracy were successful and efficient. Conducted in a panel discussion format for the first time, the session was exciting, interactive and thought-provoking.

7. In the closing remarks delivered by Mr Yoshihisa Endo, the Executive Director of the ReCAAP ISC reiterated the paramount importance of cooperation among all stakeholders, and the essentiality of information-sharing in supporting ReCAAP ISC's continued development as the foremost organisation in promoting and enhancing cooperation against piracy and armed robbery in Asia.

About the Regional Cooperation Agreement on Combating Piracy and Armed Robbery against Ships in Asia (ReCAAP), and the ReCAAP Information Sharing Centre (ISC)

The Regional Cooperation Agreement on Combating Piracy and Armed Robbery against Ships in Asia (ReCAAP) is the first regional government-to-government agreement to promote and enhance cooperation against piracy and armed robbery in Asia. It was finalised on 11 November 2004 and entered into force on 4 September 2006. To date, 18 States have become Contracting Parties to ReCAAP.

The eighteen Contracting Parties to ReCAAP are the People's Republic of Bangladesh, Brunei Darussalam, the Kingdom of Cambodia, the People's Republic of China, the Kingdom of Denmark, the Republic of India, Japan, the Republic of Korea, the Lao People's Democratic Republic, the Republic of the Union of Myanmar, the Kingdom of the Netherlands, the Kingdom of Norway, the Republic of the Philippines, the Republic of Singapore, the Democratic Socialist Republic of Sri Lanka, the Kingdom of Thailand, the United Kingdom and the Socialist Republic of Viet Nam.

The ReCAAP Information Sharing Centre (ReCAAP ISC) was established under the Agreement, and was officially launched in Singapore on 29 November 2006. It was formally recognised as an international organisation on 30 January 2007.

The roles of the ReCAAP ISC are to:

- serve as a platform for information exchange with the ReCAAP Focal Points via the Information Network System (IFN); facilitate communications and information exchange among participating governments to improve incident response by member countries; analyse and provide accurate statistics of the piracy and armed robbery incidents to foster better understanding of the situation in Asia;
- facilitate capacity building efforts that help improve the capability of member countries in combating piracy and armed robbery in the region; and
- cooperate with organizations and like-minded parties on joint exercises, information sharing, capacity building programme, or other forms of cooperation, as appropriate, and agreed upon among the Contracting Parties.

The ReCAAP ISC facilitates exchange of information among the ReCAAP Focal Points through a secure web-based Information Network System (IFN). Through this network, the ReCAAP Focal Points are linked to each other as well as the ReCAAP ISC on a 24/7 basis, and are able to facilitate appropriate responses to incident. The agency receiving the incident report will manage the incident in accordance to its national policies and response procedures, and provide assistance to the victim ship where possible. The agency will in turn, inform their ReCAAP Focal Point which will submit an incident report to the ReCAAP ISC and its neighbouring Focal Points.

INTERTANKO has been the voice of independent tanker owners since 1970, ensuring that the oil that keeps the world turning is shipped safely, responsibly and competitively.

Membership is open to independent tanker owners and operators of oil and chemical tankers, i.e. non-oil companies and non-state controlled tanker owners, who fulfil the Association's membership criteria. Independent owners operate some 80% of the world's tanker fleet and the vast majority are INTERTANKO members. As of January 2012, the organisation had 240 members, whose combined fleet comprises some 3,100 tankers totalling 250 million dwt. About S. Rajaratnam School of International Studies (RSIS)
