## ReCAAP ISC Weekly Report 12 -18 April 2022

### Piracy and Armed Robbery Against Ships in Asia

#### OVERVIEW

During 12-18 Apr 22, three incidents (comprising two CAT 4<sup>1</sup> incidents, and one attempted incident) of armed robbery against ships in Asia were reported to the ReCAAP ISC. The first CAT 4 incident occurred to a ship while anchored at Jakarta Anchorage, Indonesia and the second CAT 4 incident occurred to a ship while underway in the Singapore Strait. The attempted incident occurred to a semi-submersible rig while being towed by a tug boat at the Gulf of Khambat, India. In all three incidents, the crew was safe and nothing stolen.

(1) The incident at Jakarta Anchorage, Indonesia occurred to a bulk carrier on 11 Apr. In the incident, the duty oiler spotted three perpetrators on board the ship trying to enter the engine room. He immediately informed the duty officer on the bridge. The ship's alarm was raised and crew mustered. A search on board the ship was conducted with no further sighting of the perpetrators.

(2) The incident in the Singapore Strait occurred to a tanker while underway in the eastbound lane of the Traffic Separation Scheme of the Singapore Strait on 16 Apr. An unauthorised person was sighted in the vicinity of the ship poop deck in the way to the engine room. The ship's alarm was raised and a search on board the ship was conducted with no further sighting of the perpetrator. With this incident, a total of 19 incidents (comprising 18 actual incidents and one attempted incident) were reported in the Singapore Strait since January 2022.

(3) The attempted incident occurred on 8 Apr to a semi-submersible rig while being towed by a tug boat in the Gulf of Khambat, India. About six to seven persons armed with knives attempted to board the semi-submersible rig. Upon being sighted by the crew on board the tug boat, the unauthorised persons aborted the boarding attempt.

The location of the three incidents are shown in the map next page, and detailed description of the incidents are tabulated in the attachment.

<sup>1</sup> CAT (Category) 4 incident is classified as "least significant" in nature. Under this category, the perpetrators are not armed, and the crew not harmed.

## SITUATION OF ABDUCTION OF CREW IN THE SULU-CELEBES SEAS AND WATERS OFF EASTERN SABAH

There is no incident of abduction of crew reported since the last incident in January 2020 up to today, and no crew is currently being held in captivity by the Abu Sayyaf Group (ASG).

On 23 Apr 21, the Philippine Armed Forces conducted a military operation against members of the ASG during which one of the ASG leaders responsible for the abduction of crew in the area of Sulu and Tawi-Tawi had managed to escape. The threat of the abduction of crew in the Sulu-Celebes Seas and waters off Eastern Sabah remains potentially high particularly in the areas of Sulu and nearby waters off Tawi-Tawi.

The ReCAAP ISC reiterates its advisory issued via ReCAAP ISC Incident Alert dated 21 Nov 16 to all ships to reroute from the area, where possible. Otherwise, ship masters and crew are strongly urged to exercise extra vigilance while transiting the area, and report all incidents immediately to the Operation Centres of the Philippines and Eastern Sabah Security Command (ESSCOM) of Malaysia. The contact details of the Operation Centres of the Philippines and ESSCOM of Malaysia are as shown on next page.



The map shows the Sulu Sea to the north and the Celebes Sea to the south. Contact point 1 is located near Zamboanga. Contact points 2a and 2b are located near Bongao. Contact point 3 is located near Lahad Datu.

The ReCAAP ISC urges ship master and crew to report all incidents of piracy and armed robbery against ships to the nearest coastal State and flag State, exercise vigilance and adopt relevant preventive measures taking reference from the *Regional Guide to Counter Piracy and Armed Robbery Against Ships in Asia*.
